### How to configure a label for encryption

Step 1: From the Microsoft Purview compliance portal, select Solutions > Information protection > Labels  
Step 2: Locate and select label Product1.

Step 3: On the Define the scope for this label page, the options selected determine the label's scope for the settings that you can configure and where they'll be visible when they're published:

Step 4: Select Items, and Files. Deselect the other options.

Step 5: Then, on the Choose protection settings for the types of items you selected page, make sure you select Control access.

Step 6: On the Access control page, select Configure access control settings: Turns on encryption with rights management and makes the following settings visible:

Step 7: Assign permissions to specific users or groups. Add users or groups Step 7a: For users: Any authenticated users.

Step 7b: Permissions: Select View

Note: You can grant permissions to specific people so that only they can interact with the labeled content:

1. First, add users or groups that will be assigned permissions to the labeled content.

2. Then, choose which permissions those users should have for the labeled content.

Contoso, Ltd. is a consulting company that has a main office in Montreal and three branch offices in Seattle, Boston, and Johannesburg.

Existing Environment

Microsoft 365 Environment

Two users named User1 and User2 are assigned roles for Site2 as shown in the following table.

Site3 stores documents related to the company's projects. The documents are organized in a folder hierarchy based on the project.

Site4 has the following two retention policies applied:

- Name: Site4RetentionPolicy1

Locations to apply the policy: Site4

Delete items older than: 2 years

Delete content based on: When items were created

- Name: Site4RetentionPolicy2

Locations to apply the policy: Site4

Retain items for a specific period: 4 years

Start the retention period based on: When items were created

At the end of the retention period: Do nothing

### Problem Statements

Management at Contoso is concerned about data leaks. On several occasions, confidential research department documents were leaked.

### Requirements

#### Planned Changes

Contoso plans to create the following data loss prevention (DLP) policy:

- Name: DLPpolicy1

Locations to apply the policy: Site2

Conditions:

Content contains any of these sensitive info types: SWIFT Code

- Instance count: 2 to any

Actions: Restrict access to the content

### Technical Requirements

Contoso must meet the following technical requirements:

- All administrative users must be able to review DLP reports.
- Whenever possible, the principle of least privilege must be used.
- For all users, all Microsoft 365 data must be retained for at least one year.
- Confidential documents must be detected and protected by using Microsoft 365.
- Site1 documents that include credit card numbers must be labeled automatically.
- All administrative users must be able to create Microsoft 365 sensitivity labels.
- After a project is complete, the documents in Site3 that relate to the project must be retained for 10 years.

The Primary element defines the main pattern that must be detected. Since we need to match a 10-character alphanumeric string, this should be defined in the primary element.

Character proximity determines how close a supporting keyword (e.g., "SN") must be to the detected data. Since "SN" must be within six characters of the product serial number, this setting ensures a valid match.

Additional checks allow for exceptions and exclusions in the detection logic. This ensures that 1111111111 (a test serial number) is excluded from triggering a match.
