 - * Evaluate and improve the effectiveness and efficiency of data classification policies, procedures, and tools²
 - * Ensure alignment and consistency of data classification across different systems, applications, and processes²
 - * Report and communicate the status and results of data classification to relevant stakeholders²
- Monitoring data classification efforts can help the organization to manage and reduce the risks associated with data and to comply with relevant industry-specific regulatory mandates such as SOX, HIPAA, PCI DSS, and GDPR¹.
