- A. Take a snapshot of the RDS DB instance in the production account. Share the snapshot with the migration account. In the migration account, create a new KMS key that has an identical alias.
- B. Use native database toolsets to export the RDS DB instance to Amazon S3. Create an S3 bucket and an S3 bucket policy for cross-account access between the production account and the migration account. Use native database toolsets to import the database from Amazon S3 to a new RDS DB instance.
- C. Take a snapshot of the RDS DB instance in the production account. Amend the KMS key policy of the production-rds-key KMS key to give access to the migration account's root user. Share the snapshot with the migration account.
- D. Create an RDS read replica in the migration account. Configure the KMS key policy to replicate the production-rds-key KMS key to the migration account.

**Answer: C**

Explanation:

Encrypted RDS snapshots can be shared across accounts only if the KMS key that encrypts them allows the target account to use the key. The CloudOps engineer should (1) take a snapshot of the encrypted RDS instance, (2) update the production-rds-key KMS key policy to grant the migration account access, and then (3) share the snapshot with the migration account. This is the simplest, fully managed approach with the least administrative overhead.

### NEW QUESTION # 67

A company runs an application on a large fleet of Amazon EC2 instances to process financial transactions. The EC2 instances share data by using an Amazon Elastic File System (Amazon EFS) file system.

The company wants to deploy the application to a new Availability Zone and has created new subnets and a mount target in the new Availability Zone. When a SysOps administrator launches new EC2 instances in the new subnets, the EC2 instances are unable to mount the file system.

Explanation:

When you add a new EFS mount target in a new Availability Zone, that mount target has its own security group. For the EC2 instances in that AZ to mount the file system over NFS, the mount target's security group must allow inbound TCP 2049 (NFS) from the EC2 instances' security group.

If that rule isn't there, the instances can see the mount target in the same VPC/AZ but can't complete the NFS connection, so the mount fails.

### NEW QUESTION # 68

This is the standard mechanism used to assure SysOps that logs have not been altered after delivery.

- D. Create an Amazon CloudWatch data protection policy for the application log group. Configure data identifiers for the types of personal information that the application logs. Ensure that the security team has permission to call the unmask API operation on the application log group.

**Answer: D**

Explanation:

CloudWatch Logs data protection provides native redaction/masking of sensitive data at ingestion and query. AWS documentation states it can "detect and protect sensitive data in logs" using data identifiers, and that authorized users can "use the unmask action to view the original data." Creating a data protection policy on the log group masks PII by default for all viewers, satisfying the requirement to redact personal information. Granting only the security team permission to invoke the unmask API operation ensures that unredacted content is restricted. Option B (KMS) encrypts at rest but does not redact fields; encryption alone does not prevent

plaintext visibility to authorized readers. Options A and D add complexity and latency, move data out of CloudWatch, and do not provide default inline redaction/unmask controls in CloudWatch itself. Therefore, the CloudOps-aligned, managed solution is to use CloudWatch Logs data protection with appropriate data identifiers and unmask permissions limited to the security team.
