The issue described is that disabled on-premises AD accounts can still authenticate to Azure AD for up to 30 minutes. This behavior occurs when Password Hash Synchronization (PHS) is used, as authentication happens directly against the cloud copy of the password hash, which syncs periodically (every 30 minutes by default).

The proposed solution - configuring password writeback - allows users to reset or change their on-premises password from Azure AD (via self-service password reset). However, it does not affect the authentication flow or timing of disabled account status replication between AD and Azure AD.

From Microsoft documentation:

"Password writeback enables users to reset their on-premises passwords from the cloud but does not impact authentication or account disable synchronization." Therefore, configuring password writeback does not prevent a disabled user from authenticating in Azure AD until the next sync occurs.
