#Evaluation of needs (preliminary) - \$100,000

#Selection of developer - \$25,000

#Staff training - \$15,000

#Ongoing maintenance - \$20,000

Total Capitalizable Costs:

$\$500,000 + \$75,000 + \$50,000 + \$130,000 = \$755,000$
