Clause 6.1.3 further reinforces that control selection is flexible and risk-driven: "Organizations can design controls as required or identify them from any source," and "Annex A contains a list of possible information security controls... The information security controls listed in Annex A are not exhaustive and additional information security controls can be included if needed." Together, these extracts verify that the ISMS implementation is influenced by and scaled to the organization's needs and selected controls, not separated from management processes (A, D) nor mandated to include "all controls" (B).

Options C and D are incorrect because Annex A and ISO/IEC 27002 are reference sets, not the sole sources of controls - organizations can design their own. Criteria for performing risk assessments (B) are part of 6.1.2 (risk assessment process), not risk

treatment.

Thus, the correct requirement is A: Criteria for accepting identified risks.
