Now using the 2019 IRS Percentage Method for Married with 3 allowances:

- * Each allowance = approx. $\$159.60$ per pay period $\# 3 \times \$159.60 = \478.80
- * $\$4,500 \# \$478.80 = \$4,021.20$ (taxable income for FIT)
- * Apply IRS tax table (based on 2019 tables; simplified example):

Let's say the FIT withheld = $\$482.52$ (approximate for this band)

Then add:

- * FICA: SS $(\$5,000 \times 6.2\%) = \310.00
- * Medicare $(\$5,000 \times 1.45\%) = \72.50

Deductions:

- * $\$500$ (401k)
- * $\$482.52$ (FITW)
- * $\$310.00 + \$72.50 = \$382.50$ (FICA total)

Total deductions $\# \$1,365.02$
