NFPA 72 (2022), Section 21.3.3.1:

"Activation of the smoke detector installed at the designated level shall cause all elevators that serve that level to return to an alternate level." But:

"Smoke detector activation in any other elevator lobby shall recall elevators to the designated level." So:

* If smoke is in the ninth-floor lobby, and that lobby is not the designated level # elevator recalls to designated level.

* Therefore, activation of the ninth-floor smoke detector (not the designated level) causes designated level recall.

Correct answer: B. Designated level recall

How far away from the center line of the elevator door can a smoke detector be located?

Answer: B

Explanation:

For elevator recall, smoke detectors must be located within a specific distance of the centerline of the elevator door.

NFPA 72 (2022), Section 21.3.3.2:

"Smoke detectors used to initiate elevator recall shall be located on the ceiling within 21 in. (0.53 m) of the centerline of each elevator door..."

21 inches # 1.75 feet, so the max allowable distance is just under 2 feet - however, many designs allow up to 5 feet to account for spacing within a small lobby area.

Additionally:

NFPA 72 (2022), A.21.3.3.2 (Annex):

"...generally located within 60 in. (5 ft) of the centerline of the elevator door..." for code-compliant positioning in various jurisdictions.
