$$\beta_A = \beta_E \times \frac{E}{E+D(1-T)} = 1.6 \times \frac{60}{60+40(1-0.2)} = 1.6 \times \frac{60}{60+32} = 1.6 \times \frac{60}{92} = 1.6 \times \frac{15}{23} = \frac{24}{23} \approx 1.04$$

#A=#E×E+D(1#T)E=1.6×60+40(1#0.2)60=1.6×60+3260=1.6×9260=1.6×2315=2324#1.04
Company A is all-equity, so its equity beta = asset beta = 1.04. Use CAPM: $K_e = R_f + \beta(R_m - R_f) = 5\% + 1.04 \times 7\% = 12.28\%$
