To satisfy the requirement "block the users automatically when they report an MFA request they didn't initiate," you must use Fraud alert options. The documentation states that administrators can "allow users to submit fraud alerts" and "block users who report fraud" so that "reported accounts are immediately blocked until an administrator unblocks them." These options are part of the tenant's MFA service settings, not the Notifications section. In other words, simply configuring Notifications won't automatically block users who tap Report in Microsoft Authenticator; you must explicitly enable the setting to block users upon fraud reports. Therefore, the proposed solution-changing Notifications settings-does not meet the goal. The correct approach is to enable Fraud alert and select Block users who report fraud, ensuring automatic protection when users report unexpected MFA prompts.
