(cdn.studio.f5.com) This message is specifically about time drift between peers in the trust domain/DSC-not basic reachability (so B is not what it means), and it does not prove which side is "correct" (so C is too specific). It also doesn't directly mean an NTP source is "skewed" (A can be a cause, but the prompt message itself indicates the peer- to-peer time mismatch condition). (cdn.studio.f5.com)
