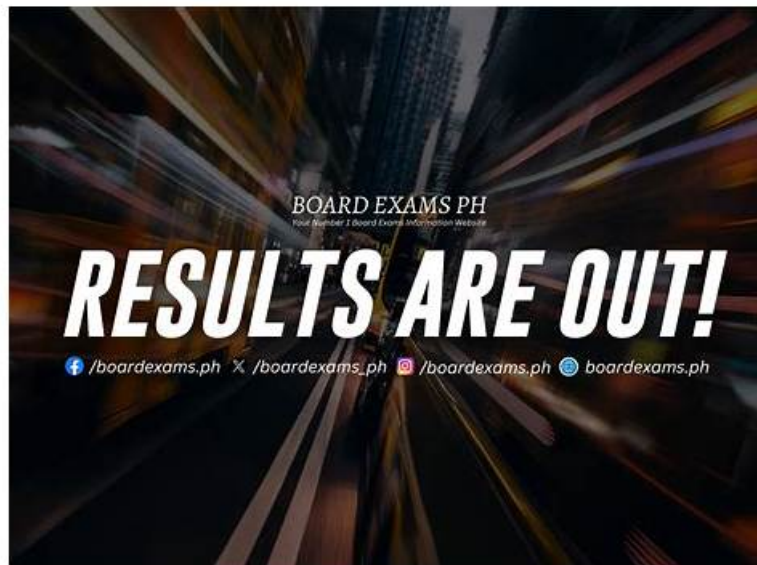

Therefore, you need to have the permission to use the Manage Banks - Master Data app in order to migrate bank data using the Migration Cockpit³.

The other tasks are not mandatory before you can migrate data for a specific object. You can select different migration methods for different objects, depending on your source system and data format. You can also have multiple migration projects in progress at the same time, as long as they do not contain the same migration objects⁴.
