A TCP entry point type means that the pattern uses a TCP port to connect to the host, while an ALL entry point type means that the pattern can use any available connection method².

It shows the payload of CI attributes and relationships, the Shazzam probe payload, and the relationships created, but not the success or failure of the individual pattern steps⁴. The success or failure of the individual pattern steps is specific to the Discovery pattern log and can be used to debug or troubleshoot the pattern execution².
