"Sensitivity shall be checked using any of the following methods:

(1) Calibrated test method approved by the authority having jurisdiction (2) Listed control equipment arranged for the purpose (3) Calibrated sensitivity test instrument of the smoke detector manufacturer" The option "test approved by the engineer" is not listed among the approved sensitivity test methods in NFPA 72, and therefore is not acceptable for compliance.

This ensures alarm audibility without causing harm.

Correct answer: B. 105 dBA
