Step 2: Calculate cost per unit (based on 5 outputs):

Cost per unit =  $$25,147,000 \div 5 = $5,029,400$ 

But the question specifically asks:

"Based on FASAB standards, calculate the full cost of 1 unit of an output..." So, the correct answer (full cost of all units) is: D). \$25.147.000

If they had asked for cost per unit, then the answer would be:

= \$5,029,400 # Option C

Note: Option C is a distractor here and would only be correct if the question specifically asked for per unit cost.
