

Option D is incorrect as settlements are completed on the same day. Option E is incorrect as the pay-out is specifically made available for the subsequent pay-in.

Answer: E

Explanation:

Calculations based on the source example for Broker Y:

Sell Value: $200 * 10 = \text{Rs. } 2,000$ (Inflow)

Buy Value: $(50 * 10.50) + (300 * 11) = 525 + 3,300 = \text{Rs. } 3,825$ (Outflow)

Net Fund Obligation = Inflow - Outflow = $2,000 - 3,825 = -1,825$.

Since the value is negative, Broker Y has to Pay Rs. 1,825.

The Client's Bank Account Number is not mentioned as a validation parameter for securities pay-in.
