1. Martin v. Hunter's Lessee	Facts: The dispute concerned land in the Northern Neck formerly owned by Lord Fairfax. The plaintiff claimed title under a Virginia patent issued in 1789, alleging escheat or forfeiture of Fairfax's title. The defendant claimed title as devisee under Fairfax's will. The case implicated the Treaty of Peace of 1783 and the Treaty of 1794, which were argued to protect the defendant's title. After the Supreme Court reversed the Virginia court's decision and remanded, the Virginia court refused to comply with the mandate, prompting a second writ of error. Issue: Does the Supreme Court's appellate jurisdiction extend to state court decisions involving federal treaties or statutes? Can the Court enforce its mandate against a state court? Standard: Article III, Section 2 extends judicial power to all cases arising under the Constitution, laws, and treaties of the United States. The 25th section of the Judiciary Act authorizes Supreme Court review of state court judgments where a federal treaty, statute, or authority is questioned and the decision is against the federal claim. Burden of Proof: The party invoking federal jurisdiction must show that the case arises under federal law or treaties. State courts are bound by the Constitution and laws of the United States under Article VI, and the Supreme Court has authority to ensure uniform interpretation of federal law.
2. Merrell Dow Pharmaceuticals v. Thompson	Facts: Plaintiffs alleged drug-related injuries and included a state-law claim referencing a federal statute (FDCA). Issue: Does referencing a federal statute in a state-law claim create federal question jurisdiction under §1331? Rule: No. A state claim citing a federal statute does not "arise under" federal law when Congress provides "no private federal remedy." Holding: Supreme Court affirmed—no federal jurisdiction; case be ong in state court.
3. Osborn v. Bank of the United States	Facts: The Bank of the United States was incorporated by Congress with authority to sue and be sued in federal courts. Ohio imposed a tax on the Bank, which the Bank claimed was unconstitutional. Ohio officials seized \$100,000 from the Bank.
