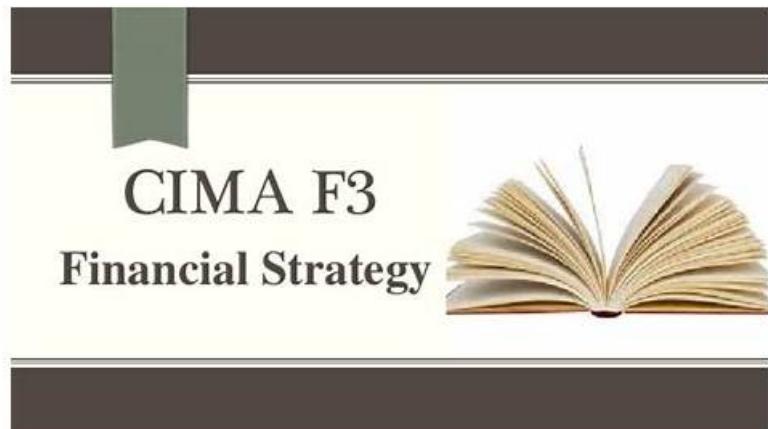

Tax @25% = 1m # Earnings = 3m

Stand-alone equity value using industry P/E 10 = $3m \times 10 = 30m$

Synergies after tax = 1m p.a. in perpetuity # value (using same multiple) = $1m \times 10 = 10m$ Value of F to X = $30m + 10m = 40m$

Offer of 30m is below this, so Board should reject on that basis.
