any associated measures the company has taken to meet safety objectives, such as mitigations to improve performance on these red-team tests and strengthen overall model security.

4. Other information pertaining to the safety and reliability of dual-use foundation models, or activities or risks that present concerns to U.S. national security.

Notably, the EO does not mandate companies to conduct or report on environmental impact studies for each dual-use foundation model. Therefore, option C is not a required reporting obligation under the Executive Order.
