주제 2	<ul style="list-style-type: none"><li>CMMC Level 2 Assessment Scoping: This section of the exam measures skills of cybersecurity assessors and revolves around determining the proper scope of a CMMC assessment. It involves analyzing and categorizing Controlled Unclassified Information (CUI) assets, interpreting the Level 2 scoping guidelines, and making accurate judgments in scenario-based exercises to define what assets and systems fall within assessment boundaries.</li></ul>
주제 3	<ul style="list-style-type: none"><li>CMMC Assessment Process (CAP): This section of the exam measures skills of compliance professionals and tests knowledge of the full assessment lifecycle. It covers the steps needed to plan, prepare, conduct, and report on a CMMC Level 2 assessment, including the phases of execution and how to document and follow up on findings in alignment with DoD and CMMC-AB expectations.</li></ul>

주제 4	<ul style="list-style-type: none"> <li>Evaluating Organizations Seeking Certification (OSC) against CMMC Level 2 Requirements: This section of the exam measures skills of cybersecurity assessors and focuses on evaluating the environments of organizations seeking certification at CMMC Level 2. It covers understanding differences between logical and physical settings, recognizing constraints in cloud, hybrid, on-premises, single, and multi-site environments, and knowing what environmental exclusions apply for Level 2 assessments.</li> </ul>

#### 질문 # 150

When discussing the OSC's proposed assessment scope, the Lead Assessor learned that some laptops and workstations share a network with CUI assets, but their users do not work with CUI. These assets do not store CUI or run applications that process CUI. Reviewing the OSC's SSP, the implemented risk-based security policies, procedures, and practices raised questions and were found to be deficient. What can the Lead Assessor do in this scenario?

- A. Conduct a limited spot check to identify risks.
- B. Validate the scope because the assets do not interact with CUI.
- C. Advise the OSC PoC or Assessment Official to address the identified deficiencies.
- D. Inform the C3PAO so as to obtain advice on the way forward.

#### 설명:

##### Comprehensive and Detailed Explanation:

These laptops and workstations are Contractor Risk Managed Assets (CRMAs), as they can but are not intended to handle CUI due to policies. The CMMC Assessment Scope - Level 2 allows limited spot checks for CRMAs if SSP deficiencies raise concerns, ensuring risks are identified without expanding the assessment's scope significantly. Option A delays action, Option B shifts responsibility prematurely, and Option D ignores the deficiencies. C is correct.

CMMC Assessment Scope - Level 2, Section 2.3.2 (CRMAs), p. 5: "Limited spot checks may be conducted for CRMAs if deficiencies are noted."

#### 질문 # 151

The Lead Assessor is conducting an assessment for an OSC. The Lead Assessor has finished collecting and examining evidence from the assessment.

Based on this information, what is the NEXT logical step?

- A. Develop an assessment plan.
- B. Generate final recommended assessment results.
- C. Deliver recommended assessment results.
- D. Determine and record initial practice scores.

#### 설명:

##### The CMMC Assessment Process (CAP) defines the logical order:

\* After collecting and examining evidence, the next step is to determine and record initial practice scores (MET, NOT MET, or NA).

\* Only after practice scoring is completed are findings validated and aggregated into final recommended results.

Extract:

"Following evidence collection and review, assessors determine and record the practice status (MET/NOT MET/NA) before compiling results into final recommendations." Reference: CMMC Assessment Process (CAP), Phase 2.

### 질문 # 152

When conducting a CMMC assessment, the CCA must follow the steps outlined in the CMMC Assessment Process (CAP). This document is organized into several phases, each requiring the CCA to complete specific documents. The CAP also provides templates, some of which the Assessor must use and complete during specific phases. A CCA must complete all the following documents in Phase 1 of the CAP, EXCEPT?

- A. Virtual Assessment Evidence Preparation Template
- **B. CMMC Assessment Quality Review Checklist**
- C. CMMC Assessment Readiness Review (CA-RR) Checklist
- D. CMMC Pre-Assessment Form Data Template

Comprehensive and Detailed in Depth Explanation:

The Quality Review Checklist is a Phase 3 document, not Phase 1, unlike Options B, C, and D (Option A).

### 질문 # 153

A company is undergoing a CMMC Level 2 Assessment. During the Conduct Assessment phase, an Assessment Team member is reviewing the policies and procedures in the incident response plan.

Which assessment method is being utilized?

- A. Observation
- B. Interview
- **C. Examine**
- D. Test

정답: C

설명:

The Examine method is used when the assessor reviews documents, policies, procedures, or system artifacts to validate practices.

Extract:

"Examine: Review, inspect, or analyze assessment objects such as documents, records, and policies to determine compliance with practice requirements." Reviewing the incident response plan falls directly under Examine.

### 질문 # 154

During a company's assessment, the CCA notices that the server room door is kept open with a fan in the entryway because the cooling system is inadequate and the machines are overheating. According to the physical protection policy, the server room's keypad is the mechanism for managing and controlling access to this equipment, and only the IT team should have access to the server room. However, with the door open, the keypad is not necessary, and anyone can enter the room.

The CCA asks the IT manager how access to this room is protected while the door is open. Which response would allow the company to still meet the physical security requirement?

- A. "The CEO emailed all employees that the server room door would be kept open but only the IT team should enter."
- B. "Only employees are allowed in this area."
- **C. 'The server is located inside another room that only the IT team has access to.'**
- D. "We trust our employees not to enter the room if they are not supposed to."

정답: C

### 설명:

The Physical Protection (PE) Domain requires implementation of physical access controls to prevent unauthorized access to CUI systems. Simply trusting employees or sending communications is not sufficient.

However, if the server is located inside a secondary restricted room that only the IT team can access, then adequate physical protection controls are still in place.

### Extract from PE.L2-3.10.x (Physical Protection Practices):

"Organizations must limit physical access to systems, equipment, and environments that process, store, or transmit CUI to authorized individuals only." Thus, placing the server within an additional restricted access-controlled room ensures compliance, even if the outer door is propped open for cooling.
