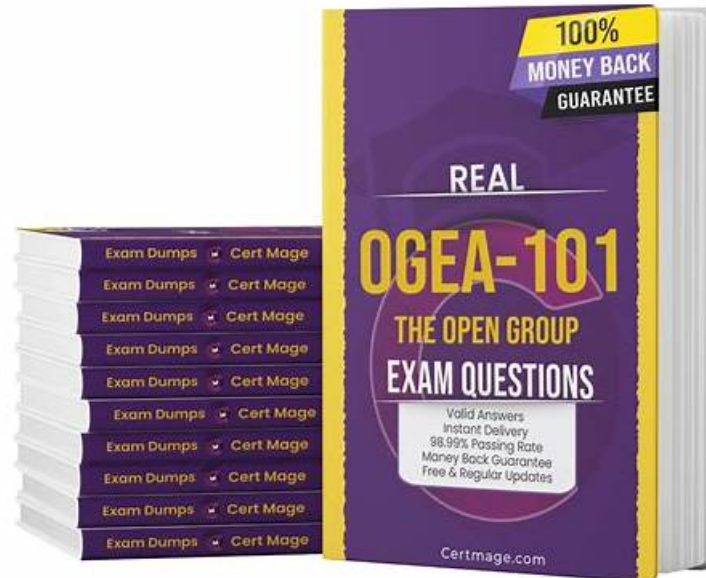

It is not primarily a mechanism for storage (that's the role of the repository), nor is it only about addressing IT concerns or preventing gaps - its primary purpose is standardising architecture outputs to support clear communication, reuse, and governance across the enterprise
