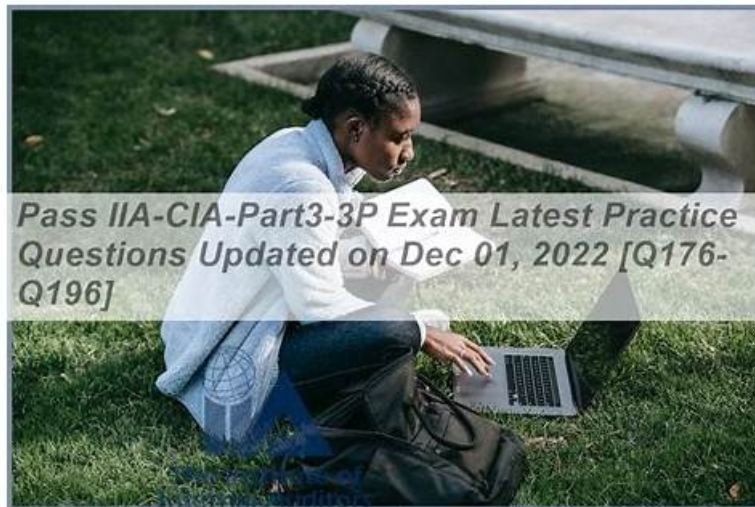

Then a US \$30,000 increase net A/R. ending net A/R must have been US \$34,500 (\$4,500 beginning net A/R + \$30,000), with ending gross A/R of US \$36,000 (\$34,500 + \$1,500). Collections were therefore US \$68,000 (\$5,000 beginning gross A/R - \$1,000 write-off + \$100,000).
