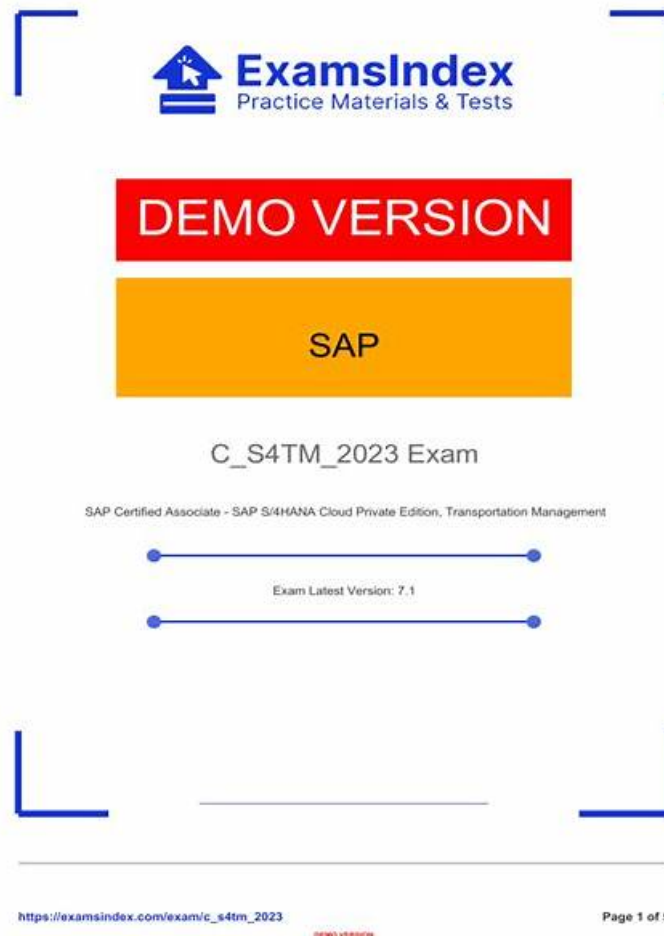

- * Validity date of the rate table (C) is defined in the rate table configuration and is not determined dynamically via conditions.
