### 問題 #37

Which attribute is NOT a required focus of continual ISMS improvement?

- A. Adequacy
- B. Effectiveness
- **C. Importance**
- D. Suitability

答案：C

解題說明：

Clause 10.2 (Continual Improvement) specifies that the organization must "continually improve the suitability, adequacy and effectiveness of the information security management system." This makes it clear that three attributes are explicitly required to be addressed:

\* Suitability: ensuring the ISMS continues to meet organizational needs in changing contexts.

\* Adequacy: ensuring the ISMS covers the necessary scope and provides sufficient control coverage.

\* Effectiveness: ensuring the ISMS achieves intended outcomes in protecting information security.

The word "importance" is not part of the continual improvement requirement. Importance is implicit in prioritization of risks and actions, but it is not a required continual improvement attribute in ISO/IEC 27001.

Therefore, option D: Importance is the correct choice as it is not specified.

This distinction reinforces that continual improvement is not about subjective importance, but about systematic enhancement of the ISMS's suitability, adequacy, and effectiveness.

### 問題 #38

Which trend in information security performance is required to be considered during a management review of the ISMS?

- A. Relevant external and internal requirements changes
- **B. Achievement of information security objectives**
- C. Validity of information continuity controls
- D. Decisions related to continual improvement opportunities

答案：B

解題說明：

Clause 9.3.2 (Management Review Inputs) states that management reviews shall include:

"c) information on the information security performance, including trends in: (1) nonconformities and corrective actions; (2) monitoring and measurement results; (3) audit results; and (4) fulfilment of information security objectives." This makes achievement of information security objectives (option A) a required trend to be considered.

While external/internal requirements (C) and continual improvement opportunities (D) are also part of management review inputs, they are not specifically listed under "trends in performance." Option B is outside the direct requirement.

Thus, the verified answer is A.

### 問題 #39

Identify the missing word in the following sentence.

According to ISO/IEC 27000, the definition of risk [?] is a "process to comprehend the nature of risk and to determine the level of risk."

- A. Assessment
- B. Management

- C. Evaluation
- **D. Analysis**

答案： D

解題說明：

Comprehensive and Detailed Explanation From Exact Extract ISO/IEC 27000 standards:

ISO/IEC 27000 defines:

- \* Risk analysis: "process to comprehend the nature of risk and to determine the level of risk" (Clause 3.58).
- \* Risk assessment: the overall process of risk identification, risk analysis, and risk evaluation.
- \* Risk evaluation: compares results of risk analysis against risk criteria to determine priority.
- \* Risk management: coordinated activities to direct and control an organization with regard to risk.

Therefore, the missing word in the given definition is "analysis".

This is important for ISMS implementation: organizations must understand the distinctions. Risk analysis is the core technical evaluation stage, while assessment is the broader process including evaluation, and management refers to the overall governance of risks.

Thus, the correct verified answer is B: Analysis.

#### 問題 #40

Identify the missing word(s) in the following control relating to the Policies for information security control.

"Information security policy and topic-specific policies should be defined, approved by management, [ ? ] and acknowledged by relevant personnel and relevant interested parties, and reviewed at planned intervals and if significant changes occur."

- A. established and maintained
- B. published
- C. communicated to
- **D. published, communicated to**

答案： D

解題說明：

Comprehensive and Detailed Explanation From Exact Extract ISO/IEC 27002:2022 standards:

Annex A.5.1 (Policies for information security) states:

"Information security policy and topic-specific policies should be defined, approved by management, published, communicated to and acknowledged by relevant personnel and relevant interested parties, and reviewed at planned intervals and if significant changes occur." This confirms that the missing words are "published, communicated to." The control emphasizes not just defining and approving policies but ensuring they are actively distributed and communicated so that relevant stakeholders are aware of and acknowledge them. Options A, B, and D are partial but incomplete.

Thus, the correct answer is C.

#### 問題 #41

Which aspect of ISO/IEC 27001 requires that contractors know about the organization's information security policies?

- **A. Awareness**
- B. Nonconformity and corrective action
- C. Communication
- D. Competence

答案： A

解題說明：

Clause 7.3 (Awareness) requires:

"Persons doing work under the organization's control shall be aware of: (a) the information security policy; (b) their contribution to the effectiveness of the ISMS, including the benefits of improved information security performance; (c) the implications of not conforming with the ISMS requirements." This applies not only to employees but also contractors and external parties under the organization's control.

Competence (B) requires having skills, training, and experience, while Communication (C) covers defining communication processes (Clause 7.4). Nonconformity and corrective action (A) is part of Clause 10 (Improvement).

Therefore, the specific requirement that ensures contractors are made aware of the information security policies is found in Clause
