What is Animal Physiology? - Answer- The study of morphological, physiological and behavioral adaptations enhancing an organism's ability to survive, grow and reproduce with respect to the biotic and abiotic environment

What is the Goal of Animal Physiology? - Answer- Ecological physiology attempts to explain life by linking the proximate question: What is the adaptation and how does it work? to ultimate causation: What evolutionary pressures shaped the adaptation, i.e., Why the ecological order is the way it is?

Adaptation studies - Answer- s look at animal life history and strategy tactics to answer not only "what" and "how" but more importantly, try to understand "why" things work the way they do

Stress studies - Answer- quantify "how" animals handle environmental change and define tolerance limits (what) thereby defining the organisms fundamental niche

2. Environment influences behavior by acting on physiology
3. Integrated physiological responses have meaning only when interpreted relative to an animal's activity within its environment

George Bartholomew - Answer- ecological physiology inductive reasoning

Per Scholander - Answer- adaptations on arctic animals

The Law of Emergent Properties - Answer- as complexity increases from level to level in the biological hierarchy properties emerge that could not be predicted from lower organization levels

Barriers to free diffusion - Answer- Membranes regulate movement of molecules in and out of cells, and in doing so establish concentration gradients

Exocytosis/Secretion - Answer- Membranes can actively release substances, e.g., synaptic transmitter substances

Reception of extracellular chemical messengers - Answer- Specific extracellular messenger compounds may bind to the cell's outer surface and initiate intercellular regulatory processes
