Therefore only statement C correctly captures the recommended usage of "will"; A, B and D contradict the defined semantics of the modal verbs.

The phrase template specifies that an optional condition comes first, then subject, action, objects and finally an optional restriction. Options A-C respect this order and provide all elements: condition ("If/When ..."), subject ("system", "control unit", "printer"), action, object and a final restriction. In D the time restriction is placed at the beginning and the condition ("upon receiving a critical alert") is embedded incorrectly, violating the template's structure. In E, the object of the action ("what" the system shall display) is missing, so the sentence is incomplete. Thus, D and E do not comply.
