Flush DNS Cache:

The system may still have cached DNS entries that point to the manually configured server address. Running ipconfig /flushdns clears the DNS cache and forces the client to query the DNS server for the updated SRV records.

Set Account Type to Automatic:

The "Automatic" account type must be selected in Jabber for it to use service discovery based on SRV records. If the account type is set to "Cisco Communications Manager 9 or later," as shown in the exhibit, Jabber will use the manually configured server address rather than performing DNS-based service discovery.
