#### **NEW QUESTION #25**

Universal Containers wants to use 'Capacity Based' contractors to complete installations that often require crews and can take more than one day.

What is true about 'Capacity Based Resources'? (Choose 2 options)

#### Answer: A,C

#### Explanation:

Capacity-Based Scheduling is a simplified scheduling model (buckets of work) compared to the standard, granular optimization. Because it ignores specific travel times and start times, it has significant limitations.

- \* Option B is correct: Capacity-Based Resources (contractors) cannot be assigned Multi-Day Service Appointments. They work on a "Hours per Day" or "Jobs per Day" limit, and the system cannot span a single appointment record across multiple days for them.
- \* Option C is correct:They cannot handle Complex Work (dependencies like "Start Same Time" or
- "Follow Immediately"). Since the engine doesn't calculate their precise start time (it just ensures they have enoughhours in the day), it cannot synchronize their work with other resources.
- \* Option D is incorrect: You cannot create a Service Crew composed of Capacity-Based resources.

#### **NEW QUESTION #26**

Green Energy Solutions would like to track their vehicles' availability, so that once a Work Order is created, both a Service Resource and a vehicle need to be assigned to the work, to ensure that the resource will use an available vehicle for the job. #### Answer: D

#### Explanation:

The requirement is to schedule two distinct resources (a Human and a Vehicle) for the same job at the same time.

- \* Option C is correct.
- \* Vehicle as Service Resource: You must model the vehicle as a Service Resource (Type: Asset) to track its availability on the Gantt and prevent double-booking.
- \* Complex Work (Same Start):To ensure the vehicle and the technician are booked together, you use Complex Work dependencies. "Same Start" ensures that the vehicle appointment and the technician appointment are scheduled to begin

simultaneously.

- \* Options A and Dare incorrect because Products are not scheduled. Consuming a product does not check if the vehicle is available at that specific time, potentially leading to double-booking the van.
- \* Option Bis incorrect because "Immediately Follow" implies a sequence (Technician finishes -> Vehicle starts), which is not how a shared ride/equipment scenario works.

#### **NEW OUESTION #27**

  be good for Universal Containers to know what the original 'Scheduled Start' and the original 'Scheduled End' values were
  and compare them with the 'Actual Start' and 'Actual End' fields for reporting scheduling efficacy

#### Answer: C

#### Explanation:

The requirement is specifically to free up white space on the Gantt when a tech finishes early.

- \* Option D is correct. The Gantt chart visual blocks are drawn based on Scheduled Start and Scheduled End. If a tech finishes a 2-hour job in 30 minutes, the Gantt bar will remain 2 hours long unless the Scheduled End is updated. By using aMobile Flowto updateboththe Actuals (for reporting) and the Scheduled (for the Gantt), the bar shrinks, revealing 1.5 hours of open availability for the dispatcher to utilize.
- \* Option C is the "Purist" data view (don't change scheduled), but it fails the specific business requirement of allowing new work to be added immediately.
- \* Option A suggests creating custom fields for the original times, which is a valid part of the solution (to keep a history), but Option D describes the core functional mechanism (Flow updating the standard fields) required to achieve the Gantt behavior. The "Offline" warning in A is true but D is the more direct configuration answer.

- \* B is correct (Service Appointment): This is the most heavily customized object. You can configure field sets to control the columns

in the Appointment List, the text shown on the Gantt bar, and the fields in the tooltip (hover).

- \* C is correct (Service Resource): You can customize the resource list (left-hand side of the Gantt) to show fields like "Vehicle Type," "Skill Level," or "Phone Number" by editing the field set on the Service Resource object.
- \* Options D and E:Service Territory and Assigned Resource do not have direct field sets that control the Dispatcher Consolelayout in the same way the primary transactional objects do.

- \* Option A is correct:You must ensure yourScheduling Policyincludes theActive ResourcesWork Rule8. This rule explicitly tells the optimization engine: "Do not assign appointments to any resource where Active = False." Without this rule, the engine might still technically assign work to an inactive record if no other constraints block it.
- \* Option B(Delete) is bad practice (data loss).
- \* Option D(Excluded Resources) is for specific job-by-jobexclusions (e.g., "Don't send Bob to this specific customer"), not for global termination.
