Explanation:

Digital forensics guidance stresses:

- * If the computer is off, do not turn it on, because booting will alter files and timestamps.
- * If the computer is on and volatile data is needed (e.g., RAM), a formally trained examiner may collect it live. Otherwise, simply unplugging the system (hard shutdown) preserves volatile evidence better than a graceful shutdown.

Thus, if the evidence exists only in volatile data and the system is running, Nobles may collect it via the normal interface.
