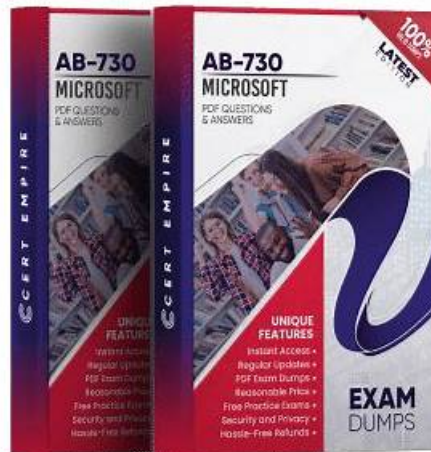

Therefore, the most likely cause of the response is that the prompt contains language that violates safety guidelines.
