The CPC Study Manual (2024) confirms, "The goal of reducing energy use should address both city and resident consumption, focusing on the entire community," supporting option D.

Option A (do nothing) ignores the potential conflict. Option B (subtle hint) is unprofessional and indirect.

Option C (report to the mayor or chair) escalates prematurely without first addressing the director. The CPC Study Manual(2024) states, "Planners should remind colleagues of the need to disclose conflicts of interest to avoid the appearance of impropriety," supporting option D.
