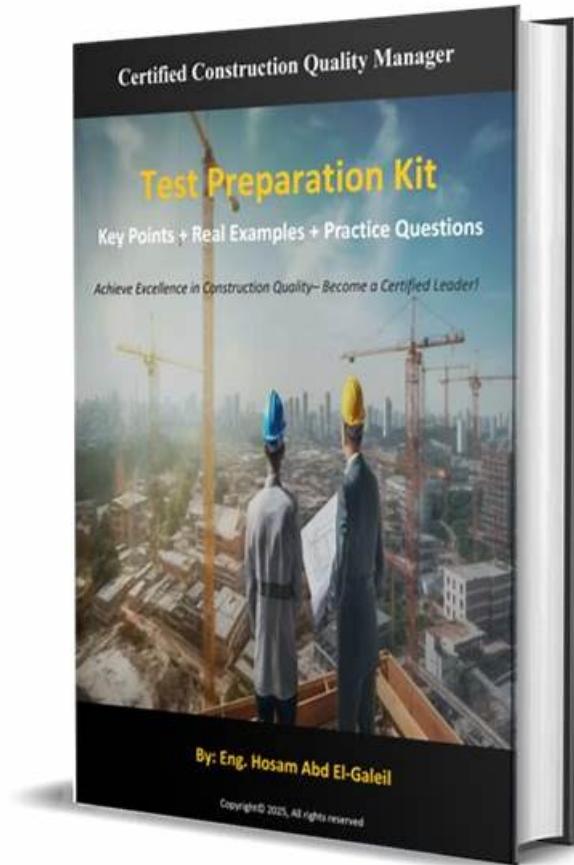

Therefore, the entity best-suited to resolve this risk is the Design-Build Team.
