* Resolution: Administrators must ensure that all devices in a high availability pair are configured to use the same reliable NTP servers to keep their system clocks aligned.

* Custom Send Strings: An HTTP monitor allows the administrator to define a "Send String" to request a specific page or URI related to the application in that pool.

* Receive Strings: The "Receive String" identifies a unique value that the application must return to be considered "Available".

* Granular Status Reporting: By deploying these monitors at the pool level, the Control Plane can mark a pool member "Offline" for one application pool if the receive string is missing, while keeping it

"Available" in another pool where the service is still healthy.
