

Also: Table A.10.14.2.1 Shows that waterflow valves and tamper switches are typical sources of supervisory signals.

So the correct answer - a waterflow alarm implies something abnormal with the fire protection system, possibly indicating a tamper switch or system supervisory issue.

Correct answer: D. A waterflow alarm has been activated
