

That is your "deliverable 4" (the scope and approach). Thus deliverable 3 is the Request for Architecture Work, and deliverable 4 is generated in Phase A. The Request triggers the cycle; the Statement of Architecture Work (in Phase A) lays down how the architecture work will proceed, including scoping and approach.
