

The APA's Planning for Equity Policy Guide(2019) recommends "creating targeted engagement plans for diverse communities and adapting methods to ensure participation," aligning with option C. Option A (participation rewards) may help but does not guarantee meaningful engagement. Option B (relying solely on community partners) risks over-dependence and may not reach all groups. Option D (survey with extended duration) is a single method and may not address broader engagement needs. The CPC Study Manual(2024) supports option C, noting, "Effective engagement involves specific plans to include diverse communities and flexibility to adjust methods."
