Option B: Solution assessment

This term generally refers to an initial evaluation of the customer's current system and business needs, usually done before the project starts (for example, during the Discover phase).

It is not the workshop where SAP standard processes are validated or where delta requirements are formally captured.

Result: Incorrect.

Option C: Solution design

The Solution Design workshop typically happens after Fit-to-Standard sessions, when teams design how the final solution will look based on confirmed requirements.

It is a design activity, not the stage where standard functionality is validated.

Result: Incorrect.

Option D: Fit-to-standard

This is the correct answer.

The Fit-to-Standard workshop is a central activity in the Explore phase of the SAP Activate methodology.

Its purpose is to:

- * Demonstrate SAP Best Practice business processes in the system (usually through a preconfigured environment).
- * Validate that the standard functionality meets the customer's business needs.
- * Identify delta requirements- only where the standard process does not meet a critical business requirement.
- * Document these delta requirements for review, prioritization, and potential configuration or enhancement in later phases.

Step 3 - Step-by-step explanation of how it works

* Preparation- Before the workshop, the project team loads SAP Best Practices into the sandbox or quality system and prepares demo scripts for each process area (e.g., Finance, Procurement, Sales).

* Execution- During the workshop:

- * The implementation team walks through SAP standard processes using live demonstrations in the system.
- * The business users and process owners review these processes.
- * Together, they confirm which processes can be adopted "as-is."

* Validation- For each process:

- * If the SAP Best Practice meets the business requirement # it is marked as Fit.
- * If not # it is marked as Delta.

* Documentation- The delta requirements are captured in a requirements management tool (such as SAP Cloud ALM or Solution Manager) with clear details for further design or configuration in later project phases.

* Outcome- The result is a list of:

- * Standard processes to be adopted.
- * Delta requirements that may need extensions, configurations, or integrations.

Step 4 - Practical Examples

Example 1:

In a Procurement Fit-to-Standard workshop, SAP demonstrates the purchase requisition and purchase order process.

- * The customer confirms that the standard workflow matches their approval process (Fit).
- * However, they request an additional approval level for high-value orders (Delta). This delta is documented for later configuration.

Example 2:

In a Finance Fit-to-Standard workshop, SAP shows the standard Accounts Payable process.

- * The customer agrees to adopt SAP's three-way match for invoices (Fit).
- * They need a specific report for tax authority submission (Delta). This delta is captured for later design.

Step 5 - Final Answer

The correct answer is D. Fit-to-standard,

because it is the workshop in which SAP standard processes are validated and delta requirements are identified and documented during the Explore phase of SAP Activate.
