Surveillance Collection - answer✓✓Collection by way of observing the data stream produced by a given data subject without interference in the data subject's activity.

Repurposing - answer✓✓Taking information collected for one purpose and using it for another (secondary) purpose.

Third-party Collection - answer✓✓Transferring data collected directly from a data subject to another organisation for their use.

Please use the following to answer the next questions:

Your company is launching a new track and trace health app during the outbreak of a virus pandemic in the US. The developers

claim the app is based on privacy by design because personal data collected was considered to ensure only necessary data is captured, users are presented with a privacy notice, and they are asked to give consent before data is shared. Users can update their consent after logging into an account, through a dedicated privacy and consent hub. This is accessible through the 'Settings' icon from any app page, then clicking 'My Preferences', and selecting 'Information Sharing and Consent' where the following choices are displayed:

- * "I consent to receive notifications and infection alerts";
- * "I consent to receive information on additional features or services, and new products";
- * "I consent to sharing only my risk result and location information, for exposure and contact tracing purposes";
- * "I consent to share my data for medical research purposes"; and
- * "I consent to share my data with healthcare providers affiliated to the company".

For each choice, an ON* or OFF tab is available. The default setting is ON for all Users purchase a virus screening service for US\$29.99 for themselves or others using the app. The virus screening service works as follows:

- * Step 1 A photo of the user's face is taken.
- * Step 2 The user measures their temperature and adds the reading in the app
- * Step 3 The user is asked to read sentences so that a voice analysis can detect symptoms
- * Step 4 The user is asked to answer questions on known symptoms
- * Step 5 The user can input information on family members (name, date of birth, citizenship, home address, phone number, email and relationship). The results are displayed as one of the following risk status: "Low", "Medium" or "High" if the user is deemed at "Medium" or "High" risk an alert may be sent to other users and the user is invited to seek a medical consultation and diagnostic from a healthcare provider.

A user's risk status also feeds a world map for contact tracing purposes, where users are able to check if they have been or are in close proximity of an infected person. If a user has come in contact with another individual classified as 'medium' or 'high' risk an instant notification also alerts the user of this. The app collects location trails of every user to monitor locations visited by an infected individual. Location is collected using the phone's GPS functionality, whether the app is in use or not; however, the exact location of the user is 'blurred' for privacy reasons. Users can only see on the map circles. Which of the following is likely to be the most important issue with the choices presented in the 'Information Sharing and Consent' pages?
