This verification step underpins inventory and financial accuracy and precedes acceptance, staging, and putaway.

Matching a packing list to an invoice is an accounting three-way match task, not a receiving floor responsibility. Selecting carriers or determining how much to purchase are procurement/transport decisions made before arrival. By aligning received quantities with the PO, the warehouse ensures correct receipts, initiates discrepancy handling for shortages/overages, and updates inventory records accordingly.
