[A] DLP helps protect confidential information such as financial records, personally identifiable information (PII), health data, or intellectual property by monitoring and controlling how this data is accessed, shared, or transmitted.

Organizations have sensitive information under their control, such as:

financial data

proprietary data

credit card numbers

health records

social security numbers

To help protect this sensitive data, and to reduce the risk from oversharing, they need a way to help prevent their users from inappropriately sharing sensitive data with people who shouldn't have it. This practice is called data loss prevention (DLP).

[D] Microsoft Purview Communication Compliance provides the tools to help organizations detect regulatory compliance (for example, SEC or FINRA) and business conduct violations such as sensitive or confidential information, harassing or threatening language, and sharing of adult content. Communication Compliance is built with privacy by design. Usernames are pseudonymized by default, role-based access controls are built in, investigators are opted in by an admin, and audit logs are in place to help ensure user-level privacy.

Policy1 applies (7 years for all Teams).

Conflict rule: For retention, the longest duration wins.

Statement 2: User1 can see the message sent by User2 for up to seven years.

Location = Private 1:1 chat (User2 # User1).

For User1's mailbox: Policy1 applies (7 years).

For User2's mailbox: Policy2 applies (5 years).

Retention in Teams chats is per-user, so each participant may have different durations.

For User1, the retention is 7 years.

Statement 3: The message deleted by User1 will be moved to the SubstrateHolds folder.

Location = Team2 channel.

User1 deletes the message, but retention policy (Policy1) applies (7 years).

Retention overrides user deletion: message is moved to the SubstrateHolds folder in the hidden mailbox for preservation.

Microsoft 365 Copilot can summarize content only when the service can access the file using the user's permissions. Content protected with Double Key Encryption is not accessible to Microsoft cloud services (including Copilot); as a result, Copilot cannot open or process DKE-protected files for any user, even if they can open the file themselves in Office apps. Therefore, no user can use Microsoft 365 Copilot to summarize File1.
