### 질문 # 18

Which action must top management take to provide evidence of its commitment to the establishment, operation and improvement of the ISMS?

- A. Ensuring information security objectives are established
- B. Producing a risk assessment report
- C. Implementing the actions from internal audits
- D. Communicating feedback from interested parties to the organization

정답: A

### 설명:

Clause 5.1 (Leadership and Commitment) requires top management to demonstrate leadership by:

\* "ensuring the information security policy and the information security objectives are established and are compatible with the strategic direction of the organization;"

\* "ensuring the integration of the ISMS requirements into the organization's processes;"

\* "ensuring that the resources needed for the ISMS are available;"

Among the options, the one explicitly mandated is ensuring that information security objectives are established. Risk assessments (C) and implementing audit actions (D) are responsibilities of management but not the direct leadership evidence required in Clause 5.1. Communicating interested party feedback (A) is relevant but not specifically cited as leadership evidence. Thus, the verified answer is B.

### 질문 # 19

Which activity is a required element of information security risk identification?

- A. Determine the risk owners
- B. Determine the level of risk
- C. Prioritize the risk for treatment
- D. Consider the likelihood of the occurrence

정답: A

### 설명:

Clause 6.1.2 defines the mandatory elements of risk assessment. Under risk identification, the standard requires: "identifies the information security risks:1) apply the information security risk assessment process to identify risks...; and2) identify the risk owners." By contrast, considering likelihood and determining levels of risk (options B and D) are part of risk analysis(6.1.2 d) "assess the realistic likelihood..."; "determine the levels of risk"), and prioritization for treatment (option C) is part of risk evaluation(6.1.2 e) "prioritize the analysed risks for risk treatment"). Therefore, the specific activity that belongs to risk identification is to identify the risk owners. This sequencing is prescribed to ensure each risk has a designated owner responsible for decisions on treatment and acceptance downstream.

#### 질문 # 20

Which item is required to be defined when planning the organization's risk assessment process?

- A. How the effectiveness of the method will be measured
- B. The parts of the ISMS scope which are excluded from the risk assessment
- C. The criteria for acceptable levels of risk
- D. There are NO specific information requirements

정답: C

설명:

Clause 6.1.2 (Information security risk assessment) requires organizations to "define and apply an information security risk assessment process that... establishes and maintains information security risk criteria, including criteria for accepting risk." This means that acceptable levels of risk (risk acceptance criteria) must be explicitly defined. These criteria ensure consistent decision-making when evaluating whether identified risks need further treatment or can be tolerated.

Option A is incorrect because exclusions relate to the ISMS scope (Clause 4.3), not risk assessment planning.

Option B is not a requirement; effectiveness of risk assessment methods is not required to be measured, though methods must be applied consistently. Option D is false-the standard clearly specifies required elements for risk assessment.

Thus, the correct answer is C: The criteria for acceptable levels of risk.

#### 질문 # 21

What is the definition of a threat according to ISO/IEC 27000?

- A. A weakness of an asset or a control that can be exploited
- B. A single or a series of unwanted or unexpected information security events
- C. The risk remaining after risk treatment
- D. A potential cause of an unwanted incident which can result in harm to a system or organization

정답: D

설명:

Comprehensive and Detailed Explanation From Exact Extract ISO/IEC 27000 standards:

According to ISO/IEC 27000:2018, Clause 3.74, a threat is defined as:

"Potential cause of an unwanted incident, which can result in harm to a system or organization." This definition directly matches option A.

\* Option B refers to an "information security incident" (ISO/IEC 27000:2018, Clause 3.32).

\* Option C describes a "vulnerability" (ISO/IEC 27000:2018, Clause 3.67).

\* Option D refers to "residual risk" (ISO/IEC 27000:2018, Clause 3.61).

The standard emphasizes that threats exploit vulnerabilities, causing incidents that can harm information confidentiality, integrity, and availability. Correctly identifying threats is critical for risk assessment (Clause 6.1.2). Thus, the correct definition per ISO/IEC 27000 is A.

#### 질문 # 22

Which benefit is NOT relevant by implementing an ISMS for an organization?

- A. Information security compliance will increase stakeholder trust in the organization
- B. Information security risks are assessed and the probability and/or impact reduced
- C. Information security controls are tailored to suit the organization's specific circumstances

- D. Information security staff will be qualified to ISO/IEC 27001 Foundation level

정답: D

설명:

The benefits of implementing an ISMS under ISO/IEC 27001 are well established. Clause 0.1 (General) explains that an ISMS provides a systematic approach to managing sensitive information and "preserves confidentiality, integrity, and availability of information by applying a risk management process and gives confidence to interested parties that risks are adequately managed."

Option A is correct as a benefit, since trust and confidence from stakeholders is an outcome of compliance.

Option C is also a benefit, since controls are chosen and tailored based on organizational context and risk assessment (Clause 6.1.3). Option D reflects another real benefit-reducing the probability and/or impact of incidents through effective risk management. However, staff qualifications (option B) are not guaranteed benefits of implementing an ISMS. While training and competence (Clause 7.2) are required, the standard does not require or provide ISO/IEC 27001 Foundation-level certification for staff. That is an external training/certification scheme, not an ISMS outcome.

Therefore, the benefit NOT relevant to implementing ISO/IEC 27001 is B.
