質問 # 49

What process involves partnering with public, private, and non-profit sectors to develop physical improvements based on the unique arts and culture attributes of a community?

- A. Scenario planning
- B. Design charrette

- C. Public realm activation
- D. Creative placemaking

正解: D

Creative placemaking involves collaboration between public, private, and non-profit sectors to leverage a community's arts and cultural assets for physical improvements, enhancing community identity and vitality.

Option A (creative placemaking) matches this description. The APA's AICP Certification Exam Content Outline(2022), under "Areas of Practice," defines creative placemaking as "a process that partners with multiple sectors to use arts and culture for community development and physical improvements." Option B (public realm activation) focuses on activating public spaces but not specifically through arts. Option C (design charrette) is a participatory design process, not necessarily arts-focused. Option D (scenario planning) is a strategic tool, not a development process. The CPC Study Manual(2024) states, "Creative placemaking uses arts and culture through multi-sector partnerships to create physical improvements," supporting option A.

One of your city's most diverse zip codes is located in the subarea targeted for the next neighborhood plan. To increase early involvement among the diverse population of this community, the planner should:

- A. Attend meetings of local organizations in advance of the planning process starting.
- B. Invite a diverse set of community leaders to a public hearing at city hall.
- C. Hold a charrette at the local middle school in the planning process.
- D. Send a multi-lingual brochure to registered voters in the community about the planning process.

正解: A

解説:

Early involvement in a diverse community requires building trust and understanding the community's needs before formal planning activities begin. Attending meetings of local organizations (option D) allows planners to engage directly with residents, understand their concerns, and establish relationships, which is critical for meaningful participation. The AICP Code of Ethics and Professional Conduct(2022) emphasizes under Section A, Principle 1(f), that planners should "seek social justice by working to expand choice and opportunity for all persons, recognizing a special responsibility to plan for the needs of the disadvantaged and to promote racial and economic integration." This principle supports proactive engagement with diverse groups. Additionally, the APA's Planning for Equity Policy Guide(2019) recommends "engaging with community organizations early to build trust," especially in diverse areas, as a best practice for inclusive planning. Options A, B, and C, while useful later, are less effective for early involvement: charrettes (A) and public hearings (B) are typically later-stage activities, and brochures (C) lack the direct interaction needed to build trust.

Scenario

You are responsible for recommending contracts to the city council. Your immediate supervisor has asked you to prepare a recommendation for a large contract for an individual you know is a good friend of your supervisor. After reviewing the contract, you conclude that the contract amount is not commensurate with the scope of work provided. You believe the contract is a waste of taxpayer dollars if it were to be granted. What might you do if your supervisor pressures you for a favorable recommendation?

Explanation

If you have any doubt about your conclusion, you might present the situation to a mentor or to a planner who is not involved in the situation (in another jurisdiction, for example) to discuss it. (Rule of Conduct 18) Planners are responsible to their employers; you might go to your supervisor with clear information on which your analysis was based, such as prices asked by other consultants for similar work, and point out your concerns. Your supervisor may appreciate your honesty and professionalism and accept your recommendation.

Should you be required to falsify your recommendation, other options might be to "blow the whistle" or to go to an attorney. If

supervisor is member of AICP, file an ethics charge against your supervisor (Procedure 5) or ask for an advisory ruling about your own conduct (Procedure 3)

質問 # 52

An AICP planner, working in a public agency, is reviewing site plan applications when they notice that many of the applicants are checking the box marked "no new surface water runoff." The planner knows, based on the site plans, that most of these projects feature new parking lots, increasing runoff into nearby lakes. The planner reports this to their supervisor, also AICP, who tells the planner to simply accept what the applicants are saying. According to the AICP Code of Ethics, what should the planner do?

- A. Tell the supervisor this would be an ethical violation to knowingly provide inaccurate information and refuse to sign off on the permits.
- B. Tell a reporter friend this type of fraudulent activity is why area lakes are being polluted, hoping a news article will change public policies.
- C. Threaten to file an ethics misconduct complaint unless the supervisor agrees to further investigate the matter.
- D. Request a written advisory opinion from AICP's Ethics Officer.

正解: A

解説:

The AICP Code of Ethics and Professional Conduct (2022) emphasizes integrity and accuracy in planning work. Section B, Rule of Conduct 1 states, "We shall not deliberately...commit a wrongful act...which reflects adversely on our professional fitness," and Rule 3 states, "We shall not...knowingly provide inaccurate information." The planner's knowledge that the site plans will increase runoff contradicts the applicants' claims, and accepting this without action would be knowingly providing inaccurate information, violating these rules. Option A (telling the supervisor this is an ethical violation and refusing to sign off) aligns with the planner's duty to uphold integrity and avoid wrongful acts. Option B (leaking to a reporter) violates Rule 10, which prohibits "public disclosure of confidential information" without authorization.

Option C (requesting an advisory opinion) is a valid step but not the first action, as the planner must address the issue directly with the supervisor first. Option D (threatening an ethics complaint) is premature and confrontational, not aligned with the Code's emphasis on professional resolution. The CPC Study Manual (2024) reinforces that planners must "act with integrity and correct inaccuracies," supporting option A.

The movement of cotton textile mills from New England to the South represented a trade-off between outlays for:

The migration of cotton textile mills from New England to the South in the late 19th and early 20th centuries was driven by cost advantages, primarily lower labor and land costs in the South. The APA's AICP Certification Exam Content Outline (2022), under

"Fundamental Planning Knowledge," states, "The movement of textile mills to the South was a trade-off between high labor and land costs in New England and lower costs in the South." Options A, B, and D (involving rent, fuel, transport) were less significant factors. The CPC Study Manual (2024) confirms, "Mills moved South for cheaper labor and land, accepting other cost trade-offs," supporting option C.
