Therefore, the ANALYST role will have SELECT privilege on all tables and views in DatabaseA_clone.Schema1, but not USAGE privilege on the database or schema. The type of view (secure or non-secure) does not affect the cloning of privileges.

Therefore, the minimal privileges on the warehouse that should be granted to the role to meet the requirements for the application are MONITOR and USAGE. Option A is incorrect because the OPERATE privilege on a warehouse grants the ability to start, stop, resume, and suspend the warehouse, which is not required for the application. Option B is incorrect because the MODIFY privilege on a warehouse grants the ability to alter the warehouse properties, such as the size, auto-suspend, and auto-resume settings, which is not required for the application. Option E is incorrect because the OWNERSHIP privilege on a warehouse grants the ability to drop the warehouse, grant or revoke privileges on the warehouse, and transfer the ownership to another role, which is not required for the application.

The CURRENT_CLIENT function is not suitable for this purpose, because it returns the IP address of the client that is connected to Snowflake, which is not related to the user's identity.
