Identify and document all possible risks, regardless of whether they are internal or external, current or

emerging, or positive or negative³.

Understand the nature and characteristics of the risks, such as their sources, causes, consequences, and interrelationships⁴.

Provide the basis for further risk analysis and evaluation, such as assessing the probability and severity of the risks, and prioritizing the risks according to their significance and urgency⁵.
