NFPA 72 (2022), Section 21.3.3.1:

"Activation of the smoke detector installed at the designated level shall cause all elevators that serve that level to return to an alternate level." But:

"Smoke detector activation in any other elevator lobby shall recall elevators to the designated level." So:

\* If smoke is in the ninth-floor lobby, and that lobby is not the designated level # elevator recalls to designated level.

\* Therefore, activation of the ninth-floor smoke detector (not the designated level) causes designated level recall.

Correct answer: B. Designated level recall

At which height above the floor is the sound level measured for public and private mode audible devices?

Sound level readings for fire alarm audible notification appliances must be taken at a consistent, standardized height to ensure compliance with required dBA levels.

NFPA 72 (2022), Section 18.4.6.1:

"Sound pressure level measurements shall be taken with a sound level meter positioned 5 ft (1.5 m) above the floor in the area required to be served by the system." This applies to both public mode (e.g., schools, offices) and private mode (e.g., staff-only zones like hospitals).

Correct answer: B. 5.0 feet (1.5 meters)

"A visual examination of a system or portion thereof to verify that it appears to be in operating condition and is free of physical damage." Testing, on the other hand, involves functional activation.  
Correct answer: D. Visual inspection only

**Answer: A**

Explanation:

\* Batteries shall be marked with the month and year of manufacture
