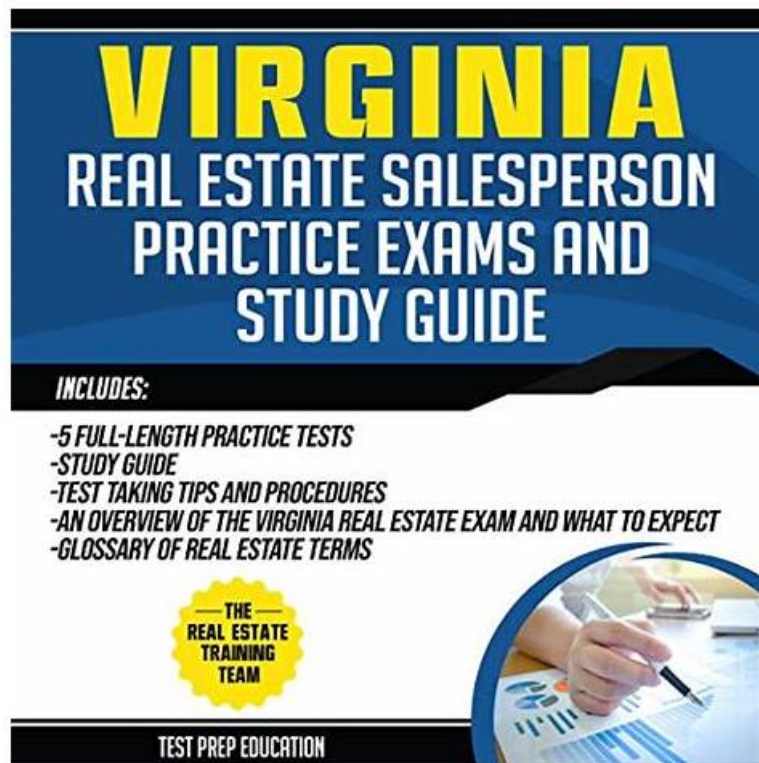

Even if a buyer requests this information, agents must not disclose it.

Other options are illegal and unethical.
