What is the best estimate of YYY's share price?

Explanation:

Step 1 - Find TTT's P/E ratio

Profit for the year (TTT) = \$25m

Shares in issue = 100m # EPS = 25 / 100 = \$0.25

Share price = \$2.00

$P/ETTT = 2,000.25 = 8$ Step 2 - Apply this P/E to YYY Profit for the year (YYY) = \$15m

Value of YYY's equity = $15 \times 8 = \$120m$

Shares in issue (YYY) = 200m

Price per YYY share = $\$120 / 200 = \0.60

Price per YYY share = $\$0.60 / \$0.60 = \$0.60$
