The consultant should upload the customer master data in the Quality system after the Fit-to-Standard workshop, using the SAP S/4HANA Migration Cockpit³.

* Evaluate the L2 Business-Driven Configuration Questionnaire responses. This is not required before the first Fit-to-Standard workshop, as the L2 Business-Driven Configuration Questionnaire is not available at this stage.
