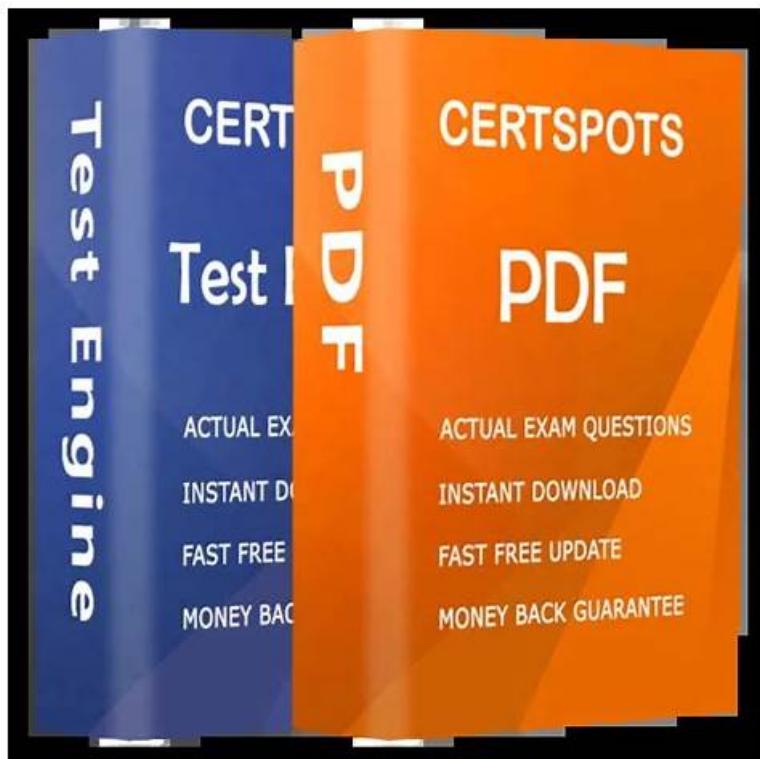





- A. The port2 interface is marked as inactive.
- B. All of the entries in the routing database table are installed in the FortiGate routing table.
- C. The default route on port2 is marked as the standby route.
- D. Both default routes have different administrative distances.

**Answer: C,D**

Explanation:

The default route via port2 has the same prefix as the route via port1 but a higher administrative distance [20/0] vs [10/0] and is not marked with ">" or "\*". This indicates it is kept as a standby/backup route, to be used only if the better route via port1 fails.

The two static default routes clearly show different administrative distances in the brackets: [20/0] for port2 and [10/0] for port1, confirming that their administrative distances are different.

Legal regulations require exemption of certain categories to protect user privacy and sensitive information, so these web categories are excluded from SSL inspection.

Move up Google in the Application and Filter Overrides section to set its priority to 1.

The "Excessive-Bandwidth" filter has a higher priority (1) and is configured to Block. Because Google applications generate significant bandwidth, they match this rule first and get blocked.

Moving the "Google" filter to priority 1 ensures that the monitor action for Google is applied before the block rule.

Set SSL inspection to deep-content inspection.

Google applications use HTTPS encryption, so the FortiGate cannot identify or control them unless SSL traffic is decrypted.

Changing from certificate-inspection (which only inspects certificates) to deep-inspection allows FortiGate to fully analyze encrypted application traffic and properly apply the Application Control rules.
