Third-party audits: conducted by independent external certification bodies.

Communicating interested party feedback (A) is relevant but not specifically cited as leadership evidence. Thus, the verified answer is B.

effectiveness (C) are important concepts elsewhere but not the direct requirement stated in this clause.
